Ref: Resolution R-32-16: Escalating Parking Fines

The WORA Board is unanimously opposed to the elimination of escalating fines for parking violations in residential districts. These escalating fines have been the law for several years but were not enforced because the Enforcement Officers did not have the technology to know when the second, third or fourth violation occurred. In addition, they are not draconian fines since they only apply to repeat offenders of the law. It is the repeat offenders that make them necessary. Especially during Special Events when there is only a \$5 differential (gamble) between the daily garage rate and the possibility of having to pay a parking violation fine.

It seems premature to consider eliminating the escalating fines before we have actual experience and specific data on collecting fines from repeat offenders and/or reducing the frequency of repeat offenders - nine days of actually issuing tickets is not sufficient experience or data to judge the effectiveness of escalating fines. Just because a law has not been enforced in the past is not a good reason to change it.

Perhaps we should revisit this issue next year after we have actual experience and specific data related to repeat offenders. If that experience shows a decline in repeat offenders and a decline in revenue from fines, we might conclude that escalating fines achieved their objective. If there is no decline in the number of repeat offenders, we should expect an increase in revenue from the repeat offender fines that could be used to offset other worth causes, e.g., transportation department expenses, food for fines program, or dare I say taxes.

In conclusion, we ask that Resolution R-32-16 be withdrawn from consideration until we have actual data on the effect of applying the existing law.
