### ID-309-16 Body Worn Cameras

Police Chief Pristoop gave a presentation on the discussion topic and spoke on the timeline for the body worn camera pilot program, the camera vendor (Panasonic), the servers installed in the Police Department, the in-house equipment that consist of 10 camera's, the network testing, the selected officers for the pilot, updates on, training and policy, the August 2016 target date for start of the pilot program for a period of 60 days with Panasonic as the provider, the joint Community and Vendor Committees and the timeline for future vendors.

Police Chief Pristoop gave an update on the discussion topic and spoke on the recent homicide in the City of Annapolis on June 26th 2016 and the arrest made in the case, the city having the lowest number in overall crime in the last 10 years, violent crime compared to prior years and the April 2016 homicide in Oxford Landing.

## ID-312-16 Zika Virus Update

Deputy Chief Simmons and Emergency Planner Williams gave a joint presentation on the discussion topic and spoke on the 35 travel associated Zika Virus cases in the State of Maryland, the 6 cases Zika Virus cases in Anne Arundel County, the community mosquito control efforts with the Department of Agriculture, the joint partnership between the City of Annapolis and the Anne Arundel County Health Department to implement a community Zika response effort, general protective measures, the 7th Annual Citywide Emergency Management Exercise scheduled on August 25, 2016 from 9 a.m. to 2 p.m. and answered questions from the committee. City Manager Andrews was also present and spoke on why spraying by the Department of Agriculture has limited effectiveness and answered questions from the committee.
