Petitions, Reports and Communications

A. Update from the Mayor

Good evening, I hope that everyone is doing well and staying healthy. I have a few things to highlight tonight.

Again, I want to thank all of the members of the council and all of the City staff for being available to get us through this budget process. I thank the department heads, each one of you, for helping me prioritize expenditures and make necessary reductions to fit where we are in the budget given the circumstances. This isn't easy. It feels like everyone is walking

away a little bit unhappy.

As I have said before, Annapolis is a resilient city and we will bounce back.

This Friday is the 19th of June. In many areas of the country, this day is commemorated as Juneteenth, the day the last enslaved peoples were informed of emancipation. Tonight I would like to issue a proclamation declaring June 19th Freedom Day in the City of Annapolis. The proclamation reads:

WHEREAS the City of Annapolis acknowledges the Emancipation of enslaved African Americans, and

WHEREAS in the City of Annapolis the history of enslaved peoples is known to have contributed in free labor to the agricultural, trade and domestic work that built this historic city, and

WHEREAS The City of Annapolis chooses to commemorate the influence of African American culture and recognizes Juneteenth to ensure that we do not forget the contributions that enslaved Africans made through blood, sweat, tears, and bondage to this nation, and

WHEREAS in a typical year, Juneteenth is commemorated with parades, cookouts, events, and family reunions in communities across the country to mark the date that the last enslaved people in America learned of their freedom, and

WHEREAS the City of Annapolis' City Dock was named in 2019 as a UNESCO City of Memory: Slave Route Project, and is recognized as one of at least 72 ports of entry where enslaved persons were brought to North America between 1619 and, in Maryland, 1774, and

WHEREAS Harriett Tubman, who was born an enslaved person in 1822 in Talbot County Maryland and escaped her life of servitude then led countless souls to freedom on the Underground Railroad, and a museum dedicated to herstory is located a one-hour drive from the City of Annapolis. All residents are encouraged to visit and learn our history, and

WHEREAS enslaved persons in the state of Maryland were not affected by the September 22, 1862 signing of the Emancipation Proclamation which declared all slaves in Southern Confederate states to be free on January 1, 1863, and

WHEREAS a new Maryland constitution was passed on November 1, 1864, prohibiting the practice of slavery in the state, and

WHEREAS the last remaining enslaved peoples in the United States got word of Emancipation on June 19, 1865 in Texas, and

WHEREAS on May 14, 2014, Maryland became the 43rd state to recognize Juneteenth as National Freedom Day.

Be it further resolved, that the City of Annapolis does hereby honor the 19th day of June as a day to commemorate America's Second Independence Day.

NOW, THEREFORE, I, GAVIN BUCKLEY, MAYOR OF THE CITY OF ANNAPOLIS, MARYLAND DO HEREBY PROCLAIM June 19 as Annapolis Freedom Day IN THE CITY OF ANNAPOLIS.

Thank you. Let's carry on with the meeting.
