I want to thank everyone who came out for the Bertina Nick cleanup at Adams Park on Saturday. In addition, I want to thank Janice Hayes Williams and Carl Snowden for organizing the event. The park is ready for spring enjoyment.

We are working on updates to our Recovery Zones, which not only proved popular with the public, but were effective at maintaining the public health. These zones provide added capacity for businesses while allowing patrons to maintain social distance.

It is a favorite week in Annapolis! It's Restaurant Week. I want to give a shout out to Erik Evans and Downtown Annapolis Partnership who have worked hard to organize this year's event.

Many of the menus include take away food, all include dine-in. either way, and support your Annapolis restaurants this week! It is less than \$40 for a three-course dinner menu. Less than \$20 per person for a two-course lunch. If you have been itching to try something new, this is the week to do it!

While you are out, please remember that the governor's mask mandate remains in effect. If you are in a store, a restaurant - unless you are at your table eating - at the gym, in a religious facility, at your office or workplace and even outdoors in places where you cannot maintain six feet from others, wear your mask!

Yesterday, the Capital Gazette ran a story on our office's health equity outreach team and their work. I spoke about them last month, but the work they are doing in the community has tremendous reach and value. We are so proud of their effort!

Starting in April, our Office of Emergency Management with the Anne Arundel Department of Health will be opening the Pip Moyer Recreation Center as a vaccination clinic site.

This is something I have been pushing for since the vaccines were approved back in December. Vaccine supply has been limited and that kept us from moving forward on an Annapolis location.

It is critically important for our City to get as many people vaccinated as quickly as possible so we can find our new normal and get back to business.

The work of government is often dismissed, but it is just these kinds of initiatives, bringing testing into the City, running vaccine clinics at senior homes at churches, reaching into communities of color to upend health disparities and outcomes, bringing vaccinations clinics to our community on a regular schedule - this is what government does. We are here to provide resources and services to residents as our primary function.

Public health is a very necessary component piece of that effort. For a long time all we had to offer was "stay home, wear your mask, and watch your distance." That was a terribly frustrating message.

We were able to bring testing here last spring and that was helpful to know where the virus was and how much of it was spreading in our community. A useful bit of information, but when that positivity rate and the case rates ticked up last fall, it was information nobody wanted to hear.

Now we are giving people a real light at the end of the tunnel. The vaccine is safe; millions of people have taken it. I have taken it. Our council has taken it.

Vaccinations - and staying one-step ahead of the variants - that is our path out of this pandemic. Being able to administer the vaccines at local churches including Mt Olive, Asbury, Mt Zion and Iglesia Hispana Emmanuel, bringing Pip Moyer online as a site, these are all the ways government is working to serve the people and to move our City out of the year that has been COVID-19.

None of this is easy. However, we are fighting for our residents and our businesses every day. I thank our City staff for working to move us forward!

Our MIT staff has been on the job since the pandemic began. They have been called on to ensure that everyone could work remotely, but they did not get that luxury. We all expect them to be there to solve problems quickly and efficiently. Right now, they are grieving. To our MIT staff, please know that we grieve with you.

I am sorry for the rest of the city staff and members of our community who knew and loved Patrick.

For his friends, family and loved ones who now have a hole in their lives where Patrick once was, I'd like to read a piece of poetry by WS Merwin. It is called "Separation."

May Patrick's memory be a blessing to us all.

ZONING CODE AND MUST BE IN ACCORDANCE WITH THE ANNAPOLIS SMALL CELL

SYSTEM GUIDELINES AND REGULATIONS AS PROMULGATED BY THE DEPARTMENT OF PLANNING AND ZONING." and sequentially re-letter subsequent subparagraphs.

AMENDMENT 2:

On page 6 strike lines 24 down through page 8 line 10 and insert:

"SMALL CELL SYSTEMS ARE SUBJECT TO THE FOLLOWING STANDARDS, RULES AND GUIDELINES AS PROMULGATED BY THE DEPARTMENT OF PLANNING AND ZONING. THE STANDARDS, RULES AND GUIDELINES SHALL INCLUDE BUT ARE NOT LIMITED TO THE FOLLOWING SUBJECTS:

- A. NOTICE OF INSTALLATION TO ABUTTING PROPERTY OWNERS.
- B. APPROVAL REQUIRED BEFORE INSTALLATION OR MODIFICATION.
- C. PLANS REQUIRED FOR PERMIT APPLICATION.
- D. CONSOLIDATED APPLICATIONS AND CO-LOCATIONS.
- E. DEADLINES AND REQUIREMENTS FOR OPERABILITY AND ABANDONMENT.
- F. CERTIFICATION OF WIND LOAD.
- G. CERTIFICATION OF COMPLIANCE WITH FEDERAL STANDARDS.
- H. COPIES OF COMMUNICATIONS WITH FEDERAL AGENCIES.
- I. VIOLATIONS OF THIS SECTION OR FAILURE TO COMPLY WITH THE REQUIREMENTS OF THIS SECTION OR ANY CONDITIONS ATTACHED TO A PERMIT OR CERTIFICATE OF USE SHALL CONSTITUTE A MUNICIPAL INFRACTION AND IS SUBJECT TO A FINE AS ESTABLISHED BY RESOLUTION OF THE CITY COUNCIL. NOTHING HEREIN CONTAINED SHALL PREVENT THE CITY OF ANNAPOLIS FROM TAKING SUCH OTHER LAWFUL ACTION AS IS NECESSARY TO PREVENT OR REMEDY ANY VIOLATION."

Amendment 3:

On page 8, strike lines 16 down through line 29 and substitute:

"REVISOR'S NOTE: In this Section "Micro Wireless Facility" and "Small Cell System" are is added.

No other changes are made.

"MICRO WIRELESS FACILITY." MICRO WIRELESS FACILITY MEANS:

1. ANY EQUIPMENT OTHERWISE WITHIN THE DEFINITION OF "SMALL
WIRELESS SYSTEM" WHOSE RADIO TRANSCEIVER AND ASSOCIATED HOUSING
EQUIPMENT HAS DIMENSIONS NO LARGER THAN 24 INCHES IN LENGTH, 15
INCHES IN WIDTH, AND 12 INCHES IN HEIGHT AND AN EXTERIOR ANTENNA, IF
ANY, NO LONGER THAN 11 INCHES; AND

2. WHERE SUCH EQUIPMENT IS SUSPENDED ON STRAND STRUNG BETWEEN EXISTING UTILITY POLES IN COMPLIANCE WITH APPLICABLE CODES BY A COMMUNICATIONS SERVICE PROVIDER AUTHORIZED TO OCCUPY THE RIGHTS-OF-WAY.

"SMALL CELL SYSTEM." SMALL CELL SYSTEM MEANS ANY SHORT RANGE EQUIPMENT INSTALLED FOR THE PURPOSE OF SUPPLEMENTING OR EXTENDING WIRELESS COMMUNICATIONS COVERAGE IN A LOCALIZED AREA. "SMALL CELL SYSTEM" INCLUDES:

1. ANY POLE, STRAND, OR OTHER STRUCTURE USED TO SUPPORT A SYSTEM OR TO WHICH A SYSTEM IS ATTACHED; AND

2. ANY RADIO TRANSCEIVER, ANTENNA, COAXIAL OR FIBER-OPTIC CABLE, REGULAR OR BACK-UP POWER SUPPLY, AND COMPARABLE EQUIPMENT, REGARDLESS OF TECHNOLOGICAL CONFIGURATION; AND ANY ANCILLARY OR ACCESSORY STRUCTURE OR EQUIPMENT TO HOUSE ANY PART OF THE SYSTEM.

"SMALL CELL SYSTEM" DOES NOT INCLUDE A MICRO WIRELESS FACILITY." Seconded. CARRIED on voice vote.
