**B. Update from the Mayor**

Mayor Gavin Buckley  
City Council Remarks  
26 April 2021 – 7 p.m.  
Virtual Meeting

I want to thank the United States Naval Academy Athletics Association for planning our presentation of the Annapolis Key to the City to Coach Bill Belichick at halftime during this weekend’s Navy vs. Army lacrosse game at Navy Marine Corps Memorial Stadium. This event was the largest in-person stadium event the Navy has had since reopening. It was great to see people out tailgating before the game. I viewed it as a sign that we are slowly getting back on our feet and doing it responsibly.

There remains a pent-up demand for tickets and Chet Gladchuck, Naval Athletics Director, relented in getting me tickets for a very limited number of people to attend this event.

I was honored that we were able to have five of our eight councilmembers in the stadium.

The Navy put in place very specific protocols, so they couldn’t invite everyone, or allow everyone down on the field. I do know that Coach Belichick was honored to be remembered as a favorite son of his home City.

As many people already know, he loves his lacrosse as much as he loves NFL football.

Throughout the event on Saturday, we saw how the brigade leads our community. The midshipmen handled themselves, keeping their masks on and modeling the kind of

behavior we would like to see with everyone who comes to Annapolis.

In the stadium, we saw them keeping their distance, but still having a good time. You could hear the crowd, especially as we were able to watch a wonderful win against Army.

I want to thank Superintendent Sean Buck and all of the people at Navy Athletics who helped to make the event a success.

Thank you from us here in the City.

And -- Go Navy!

Tonight is, we hope, our last fully virtual Annapolis City Council meeting of the whole. At our next scheduled gathering on May 10, we will be back in person in Annapolis City Council chambers.

For now, we are just allowing elected leaders, city department directors and city staff who are fully vaccinated and beyond their two-week inoculation period. Under the state of Emergency, we are only allowing this group into these in-person meetings.

If we can keep everyone safe and maintain the public health, we will be in a good position to open up further.

I want to take a moment to recognize some of our City staff who helped to make our virtual meetings possible. They put themselves at risk and exposed their health to ensure that WE could all be remote and safe to take in these meetings from home.

For this team, their jobs could not be done remotely. They were in person for each and every one of our City Council and committee meetings.

Our TV crew, Julien Jacques and Mark Hildebrand. Our MIT staff, especially manager Brian Paquin, our PIO Michelle Stephenson, and our Annapolis City Clerk's office, Regina Eldridge and Teekia Green.

Over the past few weeks, that team worked with DPW's Donovan Herald and his team to install the Plexiglas barricades and rearrange the furniture in chamber to keep us safe as well as work through the technology to ensure the public can continue to tune in virtually. Throughout the closure, the City did not miss a beat. We were one of the first municipalities to resume public meetings, virtually, after the state of emergency and closure -- and we never once had a security breach in our meetings. In addition, we were able to maintain the historic record of the pandemic era for future generations to learn from.

I want to thank this team for their perseverance and professionalism.

One final note for the public: whether committees will meet in person -- that is up to the committees and committee chairs. In person is an option open to all standing committees as of tomorrow.

For live testimony, we are going to continue to ask people to sign up online and dial-in virtually. We cannot ask the public if they have had their vaccine, a question that crosses a line for asking about personal health information. But we do want people to participate. Once we have had a chance to ensure that our public, in-person meetings among elected members and City staff are safe, and that we can do all of this while maintaining the public health, we will open things back up a little more and continue on this gradual path until we have found our new normal.

For the public, we will be allowing live testimony via Skype and those directions will be sent to you once you have selected the box to "deliver live" on the online form for public testimony.

Speaking of getting to our new normal, please go get your vaccine. The Pfizer vaccine is approved for residents 16 and up. Everyone 18 and up is eligible now that we are in stage three of our vaccine priority.

Visit the City website to find the link to get a direct appointment. You no longer need to preregister. Appointments are available at Pip Moyer on Wednesdays and Thursdays. Appointments are available Wednesday through Sunday at Navy Stadium. There are walk-ups available at Navy stadium in the morning and late afternoon.

Previously we had more people than shots. Now we have more shots than people. The jab is free. You do not need to have insurance. Go get your vaccine!

You may have heard that the City is hosting an Independence Day celebration all around our City. I am happy to confirm that rumor.

Things will kick off on July 2 with music at venues including Chambers Park. On Saturday, July 3, we'll have our parade down West and Main Streets to City Dock. There will be music, events, outdoor dining and a parade of tall ships on Saturday. On Sunday, the barge will be loaded up, sent out in the river and the City will host an amazing fireworks celebration.

If you are interested in participating in the parade, we are likely to have Gov. Hogan, County Executive Pittman and your own Annapolis mayor here - we will be honoring front line workers at the front of the parade. City Councilmembers should make plans to join in the fun.

I believe that we owe a debt of gratitude to the doctors, nurses and health department staff, the grocery store and hardware store workers, bus drivers and restaurant employees – these are the people we really needed to have in place throughout the time of COVID. I look forward to saluting them for their service.

For this event, we will be following all covid protocols. Probably masking but also distancing and whatever else is still in place at the time. We want to have this event, but we also want the City to be able to continue the reopening sequence and we need to maintain the public health.

- We held a virtual Brown Bag lunch with Alderman Savidge, Bob Gallagher and Randy Rowel, which is available for you to watch on Facebook and YouTube.
- Around the City, the Department of Recreation and Parks held 72 planting and beautification projects as part of 2021 Greenscape. Our thanks to Marisa Witlinger for organizing that event.
- Our Deputy City Manager for Resilience and Sustainability Jackie Guild moderated a discussion of water quality initiatives hosted by the Eastport Yacht Club.
- Tonight, I'd like to announce a new partnership with the Anne Arundel Watershed Stewards Academy to train residents to plant trees in their neighborhoods. It's called Replant Annapolis and Jackie will have details on that program in the coming months.
