A. Update from the Mayor

Mayor Gavin Buckley, City Council Remarks 28 February 2022 - 7 p.m. Virtual Meeting

Good evening, I want to start out tonight with a little bit of sad news, many of you know Berenice Schneider, our amazing administrative assistant in the Mayor's office. Berenice traveled to Mexico last week to be with her mother who was undergoing surgery. Rosa Noriega Del Valle made it through the procedure but unexpectedly passed away yesterday.

I would like to pass along to Berenice and her family, including her two sons Sam and Alex, as well as Sean, heartfelt condolences. We love you Berenice and I know personally how painful it is to lose your mum. We are here for you.

I also would like for us to take a few moments to think about the people of Ukraine who are being unimaginably courageous in the face of a threat that few of us could fathom: an invading Russian army; armored vehicles rolling down city streets; artillery fire and missile strikes in residential neighborhoods. The invasion is audacious but the fight the Ukranians are waging is heroic.

The international community, including the United States, have rallied in an unprecedented way to sanction Russia.

Garage. None of this would be possible without some people who have spent a lot of time working and negotiating and combing through the finer points and details of this arrangement.

First, I'd like to thank Robert Clark for assembling the ULI TAP which got the ball rolling.

Next, I need to acknowledge the City's consultant who has been shepherding this through with dozens of public meetings, hundreds and hundreds of hours of work on the external and internal mechanisms that got this deal to this point: Eileen Fogarty.

Eileen brings a lot of knowledge to the table, but also a fierce passion for getting this so close to the finish line through the fine art of compromise. She has been masterful at explaining, adjusting, and moving forward and then adjusting and explaining all over again. Thank you Eileen.

I need to thank David Jarrell, who came on as City Manager just after the RFP went out for this project. David brings so much expertise and discipline to how he conducts this work. I expect this comes from his Navy training, his work in San Diego and his more than a dozen years in Annapolis as our director of public works. Thank you David. You are a tireless champion for City taxpayers and the capital improvements and infrastructure upgrades that enhance the everyday lives of our neighbors, businesses and visitors.

I want to thank Mike Lyles and Ashley Leonard in the law office for vetting the legal specifics and working with our outside council at Squire Patton Boggs to ensure the City is protected.

Of course, the finance component is being handled by our award-winning Finance Director Jodee Dickinson, who is simultaneously wrapping up the City's budget which will be introduced in six weeks. Jodee and David have been working with Davenport and Company on the financial front protecting the City.

I thank Jodee for her diligence and perseverance on this project, but also because Jodee has been instrumental in getting the City to a good place in a financial sense. We've not only seen our bond ratings go up, but Director Dickinson also works hard to execute on the day-to-day operations. She has worked to improve the City's financial standing through transparency and her work with this Council. She ensures that our income and obligations are handled in a way that continually seeks to find balance. Thank you Director Dickinson.

Finally, I'd like to give a shout-out to our consultant CBRE for real estate and construction.

This is a big deal for our City and while we can't expect to have zero disruptions while Hillman is rebuilt, we have a plan to minimize the pain that such vital transportation projects typically bring to a community.

At the end of all this, the new garage is going to be an amazing asset that we will all be proud of: elevators that work; better lighting and security; more parking spaces; stormwater controls; EV charging stations and solar. These are the components that will

serve the next generation of residents and visitors here in our wonderful City.

I want you all to know that P3s as a financing mechanism have been shown to work well in other places. We are trying something that is a little new to us. But this public private partnership arrangement is not new to the world of municipal financing. These kinds of programs and partnerships have been working for city governments in other locations for the better part of two decades.

Let's help our businesses and residents get prepared for the change this will bring to our downtown. I urge a yes vote on the resolution.
