**A RESOLUTION** concerning

**Parking Meters - Fees**

**FOR** the purpose of amending the Fiscal Year 2020 Fees Schedule for parking meters located at certain locations in the historic district.

**WHEREAS,** Section 12.24.020 provides for an hourly rate per parking meter to be established by resolution of the City Council; and

**WHEREAS,** Resolution 33-19 adds to the Fiscal Year 2020 Fees Schedule an hourly rate for parking meters located at certain locations in the historic district of Annapolis.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fiscal Year 2020 Fees Schedule is amended as follows:
