**A RESOLUTION** concerning

**Plastic Bag Reduction - Fines**

**FOR** the purpose of imposing fines concerning the prohibition of certain checkout bags.

**WHEREAS**, Ordinance 52-20 adds Chapter 10.18 to the Code of Annapolis concerning the prohibition of certain checkout bags; and

**WHEREAS**, Resolution 68-20 imposes fines for violations of Chapter 10.18.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the following portion of the FY 2021 Fines Schedule is amended as follows:

CODE REFERENCE	DESCRIPTION	FINE FOR INITIAL OFFENSE	FINE FOR REPEAT OR CONTINUOUS VIOLATIONS
<u>10.18.030</u>	PROHIBITED CONDUCT BY DEALER	\$250 PER BAG	SECOND OFFENSE IN SAME 6-MONTH PERIOD/\$500 PER BAG
			THIRD OFFENSE IN SAME 6-MONTH PERIOD/\$1,000 PER BAG

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this resolution shall become effective upon the effective date of Ordinance 52-20.
