A RESOLUTION concerning

**Capital Improvement Program Fiscal Years 2017-2022**

**FOR** the purpose of adopting a capital improvement program for Fiscal Years 2017-2022 (July 1, 2016 - June 30, 2022).

**WHEREAS**, pursuant to Section 6.16.030 of the Annapolis City Code, on March 14, 2016, the Mayor submitted to the City Council a capital budget for the ensuing fiscal year and a Capital Improvement Program for the ensuing five fiscal years; and

**WHEREAS**, R-11-16 was referred to the Planning Commission, which held a meeting after proper public notice, to receive evidence and testimony as it judged to be relevant to the consideration of the Capital Improvement Program; and

**WHEREAS**, on May 9, 2016, the Annapolis City Council held a public hearing on the Capital Improvement Program for Fiscal Years 2017-2022; and

**WHEREAS**, the attached Capital Improvement Program for Fiscal Years 2017-2022 is submitted to the Annapolis City Council for its consideration and approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that pursuant to Section 6.16.030 of the Annapolis City Code, the capital improvement program for Fiscal Years 2017-2022, attached to this resolution and made a part hereof, be and the same is hereby adopted and approved.

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this resolution shall take effect on July 1, 2016.
