**AN ORDINANCE** concerning

**Stanton Center Lease Agreement  
Street Angel Project, Inc.**

**FOR** the purpose of approving the lease for certain City-owned property located at the Stanton Community Center, 92 West Washington Street, Annapolis, Maryland 21401 between Street Angel Project, Inc. and the City of Annapolis; providing an effective date; and matters generally relating to said Lease Agreement.

**WHEREAS**, the City is the fee simple owner of the property known and described as the Stanton Community Center, 92 West Washington Street, Annapolis, Maryland 21401, and the City has space therein to lease; and

**WHEREAS**, Street Angel Project, Inc., as a tenant, desires to lease a portion of the Stanton Community Center, as further described and depicted in the Lease Agreement attached hereto and incorporated herein; and

**WHEREAS**, Street Angel Project, Inc., as a tenant, wishes to lease a portion of the Stanton Community Center for the purpose of offering substance use and mental disorder counseling; and

**WHEREAS**, the parties desire to enter into this Lease Agreement that defines the rights, duties, and liabilities of the parties; and

**WHEREAS**, Article III, Section 8 of the Charter of the City of Annapolis requires the passage of an ordinance to authorize the lease of City-owned property.

**SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that the Lease Agreement, a copy of which is attached hereto and made a part hereof, between Street Angel Project, Inc. and the City of Annapolis for the lease of certain municipal property, is hereby approved and authorized.

**SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that in accordance with Article III, Section 8 of the Charter of the City of Annapolis, the proposed leases of City-owned property will better serve the public need for which the property was acquired.

**SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that this Ordinance shall take effect from the date of its passage.
