A **RESOLUTION** concerning

**Fines for Violating Annapolis Noise Restrictions**

**FOR** the purpose of increasing the fine for repeat violations of the City of Annapolis noise restrictions; and generally dealing with the public peace and order section of the City Code.

**WHEREAS,** Section 11.12.020 of the City Code sets noise prohibitions with the City of Annapolis, and O-28-23, Noise Prohibition City Code Update - Prohibitions and Enforcement Enhancements, authorizes new restrictions and enforcement, the City Manager shall implement fines for this section as amended by this resolution.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fines Schedule shall be amended as follows:

<b>Section</b>	<b>Type of Fine</b>	<b>Fine for Initial Office</b>	<b>Fine for Repeat or Continuous Violations</b>
<u>11.12.020</u>	<u>Public peace and order violation: Noise Prohibition</u>	<u>\$100.00 per day</u>	<u>\$200.00</u>

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the effective date of this resolution shall be its date of adoption.
