A RESOLUTION concerning

Special Events in the Annapolis Historic District during 2015

FOR For the purpose of adding the First Sunday Annapolis Chocolate Binge Festival to the list of approved special events authorizing Hawker, Peddler, and Itinerant merchant sales in the Historic District during calendar year 2015.

WHEREAS, the City Council approved R-5-15 as amended on March 23, 2015 authorizing sales at certain special events in the Historic District during 2015; and

WHEREAS, the Inner West Street Association wishes to hold an additional event to those approved pursuant to R-5-15; and

WHEREAS, the Inner West Street Business Association wishes to hold the First Sunday Annapolis Chocolate Binge Festival in the Historic District on December 6, 2015.

NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the First Sunday Annapolis Chocolate Binge Festival be added to those special events approved by R-5-15 authorizing sales of merchandise in the Historic District in conjunction with certain special events, and

BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the First Sunday Annapolis Chocolate Binge Festival be held in the geographic location as described in the accompanying Staff Report.
