A RESOLUTION concerning

**Amending Fines for Parking on Northwest Street and Parking of Motor Homes**

**FOR** the purpose of removing the fine for violating 15-minute parking on portions of Northwest Street and establishing a fine for parking violations specific to motor homes.

**WHEREAS**, pursuant to Chapter 1.20 - General Penalty and Municipal Infractions, fines are authorized in the City Code and established by resolution of the City Council; and

**WHEREAS**, Ordinance O-37-15 removes the 15-minute parking zone on Northwest Street; and

**WHEREAS**, Ordinance O-38-15 establishes Section 12.20.115 regulating the parking of Motor Homes on City streets.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2016 Fines Schedule is amended as follows:
