**SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

#### Title 7 - BUSINESS LICENSES, TAXES AND REGULATIONS

### Title 7 - BUSINESS LICENSES, TAXES AND REGULATIONS

Chapter 7.12 - Alcoholic beverages.

Section 7.12.230 - Restaurants.

- D. Restaurant-class licenses are as follows:
  - 1. Class B-1: Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and twelve midnight, Monday through Saturday. The premises shall not contain a bar open to the public.
  - 2. Class B-1.X: Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and two a.m., Monday through Saturday. The premises shall not contain a bar open to the public.
  - 3. Class B-2: Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and twelve midnight, seven days a week. The premises shall not contain a bar open to the public.
  - 4. Class B-2.X: Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and two a.m., seven days a week. The premises shall not contain a bar open to the public.
  - 5. Class B-3: Alcoholic beverages are restricted to on sale only and sales shall be only between the hours of six a.m. and twelve midnight, Monday through Saturday.
  - 6. Class B-3.X: Alcoholic beverages are restricted to on sale only and sales shall be only between the hours of six a.m. and two a.m., Monday through Saturday.
  - 7. Class B-4: Alcoholic beverages are restricted to on sale only and sales shall be only between the hours of six a.m. and twelve midnight, seven days a week.
  - 8. Class B-4.X: Alcoholic beverages are restricted to on sale only and sales shall be only between the hours of six a.m. and two a.m., seven days a week.
  - 9. Class B-3.a, class B-3.X.a, class B-4.a and class B-4.X.a: In addition to the on sale of alcoholic beverages, off sale is permitted Monday through Saturday during authorized hours.
  - 10. Class B-4.a.b and class B-4.X.a.b: In addition to the on sale of alcoholic beverages and off sale of alcoholic beverages Monday through Saturday, off sale is permitted on Sunday during authorized hours.
- D. Restaurant-class licenses are in the Class B category as follows:
  - 1. Class B-1. Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and twelve midnight, Monday through Saturday. The premises shall not contain a bar open to the public.

- <u>i.</u> <u>Class B-1.a In addition, off-sale Monday through Saturday during hours.</u>
- ii. Class B-1.b In addition, off-sale Sunday during authorized hours (special Sunday License).
- iii. Class B-1.g In addition, the sale of draft beer is permitted in refillable containers per § 12.335 of this Title.
- iv. Class B-1.X Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and two a.m., Monday through Saturday. The premises shall not contain a bar open to the public.
- 2. Class B-2. Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and twelve midnight, seven days a week. The premises shall not contain a bar open to the public.
  - i. Class B-2.a In addition, off-sale Monday through Saturday during hours.
  - ii. Class B-2.b In addition, off-sale Sunday during authorized hours (special Sunday License).
  - iii. Class B-2.g In addition to the sale of alcoholic beverages served only with meals and sales, the sale of draft beer is permitted in refillable containers per § 12.335 of this Title.
  - iv. Class B-2.x Alcoholic beverages shall be served only with meals and sales shall be only between the hours of six a.m. and two a.m., seven days a week. The premises shall not contain a bar open to the public.
- 3. <u>Class B-3 Alcoholic beverages are restricted to on-sale only, and sales shall be only between the hours of six a.m. and twelve midnight, Monday through Saturday.</u>
  - i. <u>Class B-3.a</u> In addition, off-sale is permitted Monday through Saturday during authorized hours.
  - <u>ii.</u> <u>Class B-3.b</u> <u>- In addition, off-sale Sunday during authorized hours (special Sunday License).</u>
  - iii. Class B-3.g In addition to alcoholic beverages restricted to on-sale only and sales, the sale of draft beer is permitted in refillable containers per § 12.335 of this Title.
  - iv. Class B-3.x Alcoholic beverages are restricted to on-sale only, and sales shall be only between the hours of six a.m. and two a.m., Monday through Saturday.
  - v. <u>Class B-3.x.a</u> In addition, off-sale is permitted Monday through Saturday during <u>authorized hours.</u>
- 4. <u>Class B-4 Alcoholic beverages are restricted to on-sale only, and sales shall be only between the hours of six a.m. and twelve midnight, seven days a week.</u>
  - i. Class B-4.a In addition, off-sale is permitted Monday through Saturday during authorized hours.
    - <u>Class B-4.a.b</u> In addition to the on-sale of alcoholic beverages and off-sale of alcoholic beverages Monday through Saturday, off-sale is permitted on Sunday during authorized hours.

- ii. Class B-4.b In addition, off-sale Sunday during authorized hours (special Sunday License).
- iii. Class B-4.g In addition to the on-sale of alcoholic beverages and off-sale of alcoholic beverages Monday through Saturday, the sale of draft beer is permitted in refillable containers per § 12.335 of this Title.
- iv. Class B-4.x Alcoholic beverages are restricted to on-sale only, and sales shall be only between the hours of six a.m. and two a.m., seven days a week.
- v. Class B-4.x.a In addition to the on-sale of alcoholic beverages, off-sale is permitted Monday through Saturday during authorized hours.
- vi. <u>Class B-4.x.a.b</u> In addition to the on-sale of alcoholic beverages and off-sale of alcoholic beverages Monday through Saturday, off-sale is permitted on Sunday during authorized hours.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this ordinance shall take effect upon passage.
