A RESOLUTION concerning

Director of Planning and Zoning - Christopher Jakubiak

FOR the purpose of expressly confirming the appointment of Christopher Jakubiak as the Director of Planning and Zoning for the City of Annapolis; and consenting to compensate the Director.

WHEREAS, pursuant to Section 3.08.030.F of the Annapolis City Code, the appointment and initial salary of the Director of Planning and Zoning is subject to confirmation by the City Council; and

WHEREAS, the Director of Planning and Zoning position became vacant on March 3, 2023; and

WHEREAS, Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a thorough review of Mr. Jakubiak’s qualifications and determined in her professional opinion that Mr. Jakubiak’s qualifications exceed the minimum requirements of the Annapolis Charter and that

Mr. Jakubiak, by virtue of his background, education and experience, is more than qualified to hold the position of Director of Planning and Zoning; and

WHEREAS, pursuant to the foregoing City Code provision, the City Council is required to expressly consent to the confirmation and compensation of the Director of Planning and Zoning.

NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a thorough review of Mr. Jakubiak's qualifications and determined in her professional opinion that Mr. Jakubiak's qualifications exceed the minimum requirements of the Annapolis Charter and that Mr. Jakubiak, by virtue of his background, education, and experience, is more than qualified to hold the position of Director of Planning and Zoning.

BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the City Council expressly confirms the appointment of Mr. Jakubiak to the position of Director of Planning and Zoning and consents to compensate Mr. Jakubiak as Director of Planning and Zoning in the amount of \$184,940 per annum.
