A RESOLUTION concerning

Tug of War Special Event - Fee Waiver

FOR the purpose of waiving the Harbormaster's fees for the Tug of War event hosted by the Maritime Republic of Eastport that was held in Fiscal Year 2019.

WHEREAS, R-7-18 identified the Tug of War event as a City Sponsored Special Event in Fiscal Year 2019

and approved the waiver of parking fees associated with that event; and

WHEREAS, the City Council desires to also waive the Harbormaster's fees incurred for the Fiscal Year 2019 Tug of War event; and

WHEREAS, Section 6.04.210 of the City Code further states that the fees for City Services may be waived "by resolution of the City Council pursuant to guidelines approved by the City Council."

NOW THEREFORE,

BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that there shall be a waiver of Harbormaster's fees for the Tug of War event sponsored by the Maritime Republic of Eastport that was held in Fiscal Year 2019.

AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that this resolution shall take effect from the date of its passage.
