**A RESOLUTION** concerning

**Swimming Pool Fees**

**FOR** the purpose of specifying the fees that will be charged for use of the new City of Annapolis swimming pool; and setting an effective date.

**WHEREAS,** R-16-19 specified the fees that will be charged for the use of City services during FY 2020; and

**WHEREAS,** R-20-20 amends the FY 2020 Fees Schedule to specify the fees that will be charged for use of the new City of Annapolis swimming pool effective April 1, 2020.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2020 Fees Schedule shall be amended as follows:
