WHEREAS, The current fines for abandoned vehicles are not sufficient to deter people from abandoning their vehicles

NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the Fees Schedule shall be amended as follows:

Section		Offense	Fine for Repeat or Continuous Violations
12.44.030.A	Wrecked or inoperable vehicles on public property	•	\$ 100<mark>250</mark> .00 plus damages
12.44.040.B	Keeping wrecked or discarded vehicles	\$ 100<u>250</u> .00 per day	\$ 100<u>250</u>.00 per day

AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the effective date of this resolution shall be its date of adoption.
