**A RESOLUTION** concerning

**WHEREAS,** Ordinance 37-17 repeals and re-enacts with amendments Chapter 12.28 concerning the operation

of parking places and parking lots; and

**WHEREAS**, Resolution 33-17 establishes a fine for a violation of Chapter 12.28.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2018 Fines Schedule is amended as follows:
