A RESOLUTION concerning

City Sponsored Special Events in Fiscal Year 2021 Amended

FOR the purpose of adding the Juneteenth Parade and Festival to the approved FY 2021 City Sponsored

Special Events; and waiving certain related City Fees.

WHEREAS, on April 27, 2020, the City Council adopted R-15-20 approving the City Sponsored Special Events for Fiscal Year 2021 and waiving certain related City fees.

WHEREAS, the City Council wishes to add the Juneteenth Parade and Festival to the list of approved City Sponsored Special Events for Fiscal Year 2021.

NOW THEREFORE,

BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the Juneteenth Parade and Festival is designated a City Sponsored Special Event during Fiscal Year 2021, in recognition of its significance to our heritage and public service to our City.

AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that there shall be a waiver of certain fees for the Juneteenth Parade and Festival that is identified in the Staff Report attached to this Resolution and incorporated by reference.
