**A RESOLUTION** concerning

### Special Event Permit Fee and Fines

**FOR** the purpose of setting the special event permit fee and a fine for violating Section 11.12.050 and

Chapter 14.18 of the City Code on special events.

**WHEREAS**, pending Ordinance 16-14 is a comprehensive overhaul of the City Code related to special events; and

**WHEREAS**, pending Ordinance 16-14 authorizes a special event permit fee by resolution of the City Council; and

**WHEREAS**, pending Ordinance 16-14 authorizes a fine for a violation of Chapter 14.18 by resolution of the City Council.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2015 fee schedule is amended as follows:
