**A RESOLUTION** concerning

**Forest Conservation Act Fees and Fines**

**FOR** the purpose of setting fees and fines associated with the City’s Forest Conservation Act set forth in Chapter 17.13 of the City Code.

**WHEREAS,** Ordinance 32-14 is the City’s proposed Forest Conservation Act; and

**WHEREAS,** Ordinance 32-14 authorizes the imposition of fees by resolution of the City Council; and

**WHEREAS,** Ordinance 32-14 authorizes the imposition of fines by resolution of the City Council.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2015 fee schedule is amended as follows:

This fee applies to an original submission and again for each subsequent revised submission.	\$250.00
	Forest Stand Delineation Application Fee for all others. This fee applies to an original submission and for each subsequent revised submission. For the purposes of this fee schedule, “n” is defined as the number of submissions of a Forest Stand Delineation by the same applicant for the same parcel. For example, for the first submission, n = 1, for the second submission, n=2, and so on.	\$850.00 plus n times \$30.00 per acre or fraction thereof
	Preliminary Forest Conservation Plan Application Fee for single residential lots less than five acres, including single family residential lots being subdivided where no additional buildable lots are being created. This fee applies to an original submission and again for each subsequent revised submission.	\$250.00
	Preliminary Forest Conservation Plan Application Fee for all others. This fee applies to an original submission and for each subsequent revised submission. For the purposes of this fee schedule, “n” is defined as the number of submissions of a Preliminary Forest Conservation Plan by the same applicant for the same parcel. For example, for the first submission, n = 1, for the second submission, n=2, and so on.	\$850.00 plus n times \$30.00 per acre or fraction thereof.
	Final Forest Conservation Plan Application Fee for single residential lots less than five acres, including single family residential lots being subdivided where no additional buildable lots are being created. This fee applies to an original submission and again for each subsequent revised submission.	
	Final Forest Conservation Plan Application Fee for all others. This fee applies to an original submission and for each subsequent revised submission. For the purposes of this fee schedule, “n” is defined as the number of submissions of a Final Forest Conservation Plan by the same applicant for the same parcel. For example, for the first submission, n = 1, for the second submission, n=2, and so on.	\$850.00 plus n times \$30.00 per acre or fraction thereof.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2015 fine schedule is amended as follows:
