**WHEREAS**, the Annapolis Police Department is committed to reducing crime and improving community safety; and

**WHEREAS**, Chief Michael A. Pristoop came to the City in 2008 during a time of very high crime, and by virtue of his professional qualifications, integrity and initiative, and with the support of his staff, the City benefits from all time low rates of crime, accomplished with fewer officers due to budget constraints; and

**WHEREAS**, during this trying period of turmoil, and because of incidents across the nation, Chief Pristoop has insisted on and implemented programs and training to assure that the City of Annapolis and its Police Department are positioned in an increasingly pre-emptive stance.
