**WHEREAS,** O-5-24, establishing fines required by the adoption of Ordinance 5-24, Health and Safety - City of Annapolis Plastic Bag Reduction Act, includes the authority for the City to issue certain fines; and

**WHEREAS,** The amount of those fines needs to be established by resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fees Schedule shall be amended as follows:
