**A RESOLUTION** concerning

### Capital Improvement Program Fiscal Years 2015-2020

**FOR** the purpose of adopting a capital improvement program for Fiscal Years 2015-2020 (July 1, 2014 - June 30, 2020).

**WHEREAS**, pursuant to Section 6.16.030 of the Annapolis City Code, on March 10, 2014, the Mayor submitted to the City Council a capital budget for the ensuing fiscal year and a capital improvement program for the ensuing five fiscal years; and

**WHEREAS**, on April 7, 2014, the Annapolis City Council held a public hearing on the capital improvement program for Fiscal Years 2015-2020; and

**WHEREAS**, R-12-14 was referred to the Planning Commission, which held a meeting after proper public notice, to receive evidence and testimony as it judged to be relevant to the consideration of the capital improvement program; and

**WHEREAS**, the attached capital improvement program for Fiscal Years 2015-2020 is submitted to the Annapolis City Council for its consideration and approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that pursuant to Section 6.16.030 of the Annapolis City Code, the capital improvement program for Fiscal Years 2015-2020, attached to this resolution and made a part hereof, be and the same is hereby adopted and approved.

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this resolution shall take effect on July 1, 2014.
