FOR the purpose of making changes to the Annapolis Department of Transportation's transit services and routes in order to meet the goals and objectives of the fiscal year 2015 budget.

WHEREAS, the adopted fiscal year 2015 budget included a reduction of \$3.3 million dollars from the Transportation Department's budget with the understanding of revisiting the reductions in



routes and services necessary to achieve a balanced budget; and
