A RESOLUTION concerning

### **Analysis of Impediments to Fair Housing**

**FOR** the purpose of adopting an Analysis of Impediments to Fair Housing.

- WHEREAS, the City of Annapolis, Maryland is an entitlement community under the U.S. Department of Housing and Urban Development's (HUD) Community Development Block Grant Program (CDBG); and
- WHEREAS, in accordance with the Housing and Community Development Act of 1974, as amended, each entitlement community must "affirmatively further fair housing;" and
- WHEREAS, in order to "affirmatively further fair housing," each entitlement community must conduct a Fair Housing Analysis, which identifies any impediments to fair housing choice; and
- **WHEREAS,** the City of Annapolis has prepared this FY 2015-2019 Analysis of Impediments to Fair Housing Choice.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2015-2019 Analysis of Impediments to Fair Housing Choice for the period beginning July 1, 2016 through June 30, 2020 is hereby approved,

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City of Annapolis is committed to pursue the goals and strategies to address those impediments identified in the analysis.
