## A RESOLUTION concerning

#### License for Peddlers, Hawkers, and Itinerant Merchants Not Required for Chesapeake Marine Tours, Inc. from July 1, 2016 to June 30, 2022

**FOR** the purpose of establishing that a license for peddlers, hawkers, and itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code is not required from July 1, 2016 through June 30, 2022 for Chesapeake Marine Tours, Inc.

WHEREAS, the City has entered into a series of leases with Chesapeake Marine Tours, Inc. for the lease of

certain docking spaces at the City Dock area to dock vessels and to carry on a business of operating a cruise and water taxi service of the Chesapeake Bay and its tributaries from July 1, 2016 through June 30, 2022; and

- WHEREAS, on July 25, 2016, the Annapolis City Council passed Ordinance 8-16 amending the requirements related to a license for peddlers, hawkers, and itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code; and
- WHEREAS, a license for peddlers, hawkers, and itinerant merchants is not required pursuant to Chapter 7.40.020.A.[13][14] on those days of the year and at those places and times as are designated from time to time by resolution or ordinance of the Annapolis City Council.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that a license for peddlers, hawkers, and itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code shall not be required for the following entities, days, places and times:

- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2016 June 30, 2017, as further described in a lease with the City of Annapolis dated May 13, 2011 and approved by the Annapolis City Council pursuant to Ordinance 04-11.
- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2017 June 30, 2018, as further described in a lease with the City of Annapolis dated May 1, 2012 and approved by the Annapolis City Council pursuant to Ordinance 02-12.
- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2018 June 30, 2019, as further described in a lease with the City of Annapolis dated May 16, 2013 and approved by the Annapolis City Council pursuant to Ordinance 02-13.
- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2019 June 30, 2020, as further described in a lease with the City of Annapolis dated June 25, 2014 and approved by the Annapolis City Council pursuant to Ordinance 04-14.
- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2020 June 30, 2021, as further described in a lease with the City of Annapolis dated March 30, 2015 and approved by the Annapolis City Council pursuant to Ordinance 02-15.
- Chesapeake Marine Tours, Inc., City Dock Area, July 1, 2021 June 30, 2022, as further described in a lease with the City of Annapolis dated June 8, 2016 and approved by the Annapolis City Council pursuant to Ordinance 15-16.

AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this resolution shall take effect from the date of its passage.
