**BY** repealing and re-enacting with amendments the following portion of the Code of the City of Annapolis, 2015 Edition 2.12.030

**SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

#### **TITLE 2 - ADMINISTRATION**

**CHAPTER 2.12 - MAYOR** 

Section 2.12.030 - City Administrator MANAGER.

The City Administrator MANAGER shall meet the qualifications and have the duties set forth in the Charter.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this ordinance shall take effect 50 days after the adoption of Charter Amendment CA-3-16.
