A RESOLUTION concerning

Non-Profit Vendors During Fall Boat Shows 2017

FOR the purpose of authorizing sales by certain vendors in the City Dock area of the Historic District during the Fall 2017 U.S. Sailboat and Powerboat Shows.

WHEREAS, on July 25, 2016, the Annapolis City Council passed Ordinance 8-16 amending the requirements related to a license for peddlers, hawkers, and itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code; and

WHEREAS, Section 7.40.090 of the City Code allows the City Council to designate certain days of the year, places and times when peddlers, hawkers and itinerant merchants may be licensed to sell in the Historic District or a nonresidential area.
