**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2019 Fees Schedule shall be as attached.

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2019 Fees Schedule shall take effect on July 1, 2018, or on the date of adoption, whichever date is later.
