**A RESOLUTION** concerning

#### **Submission of Proposed Union Agreement - Local 1926**

**FOR** the purpose of submitting a written memorandum of Collective Bargaining Agreement between the City of Annapolis and Local 1926 for the Fiscal Years 2019 through 2022 to the City Council for its ratification or rejection.

**WHEREAS**, the City of Annapolis and Local 1926 employee organization has, through appropriate officials or their representatives, negotiated collectively and in good faith with respect to the terms and conditions of employment of employees in the organization; and

**WHEREAS**, pursuant to Section 3.32.060D of the Code of the City of Annapolis, a written memorandum of

Collective Bargaining Agreement between the City of Annapolis and the Local 1926 for the Fiscal Years 2019 through 2022 is hereby submitted to the City Council for its ratification or rejection.

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City Council hereby adopts the Collective Bargaining Agreement between the City of Annapolis and Local 1926 for the Fiscal Years 2019 through 2022.

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the terms of the Collective Bargaining Agreement between the City of Annapolis and Local 1926 for the Fiscal Years 2019 through 2022 shall take effect from July 1, 2018.
