WHEREAS, pursuant to Section 3.32.060D of the Code of the City of Annapolis, a written memorandum of Collective Bargaining Agreement between the City of Annapolis and the Local 400 for the Fiscal Years 2019 through 2022 is hereby submitted to the City Council for its ratification or rejection.

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the terms of the Collective Bargaining Agreement between the City of Annapolis and Local 400 for the Fiscal Years 2019 through 2022 shall take effect from July 1, 2018.
