WHEREAS, the Maryland Health Care Commission approved the Anne Arundel Medical Center's application

- WHEREAS, on May 22, 2018, the Prince George's County Circuit Court upheld the Commissions' decision to award clearance to Anne Arundel Medical Center to offer a cardiac surgery program within Annapolis and Anne Arundel County, and
- WHEREAS, the UM Capital Health Region has appealed the decision of Prince George's County Circuit Court resulting in a further delay of the much needed cardiac surgery program within Annapolis and Anne Arundel County; and

- WHEREAS, there are no cardiac surgery programs within Annapolis or Anne Arundel County, and
- WHEREAS, Annapolis is the capital of the State of Maryland, and one of few state capitals in the United States without a cardiac surgery program, and
- WHEREAS, access to prompt, accessible and affordable cardiac services is a critical factor in the future welfare of not only Annapolis residents, but also the hundreds of thousands of visitors it receives each year, and

BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the Maryland Health Care Commission conducted a comparative review of Anne Arundel Medical Center's Certificate of Need application and the Commission's decision to approve Anne Arundel Medical Center's cardiac surgery program should be upheld on appeal.
