AN ORDINANCE concerning

Public Peace - Noise Prohibition

FOR the purpose of making technical corrections to the City of Annapolis Environmental and Motor Vehicle Noise Standards.

BY repealing and re-enacting with amendments the following portions of the Code of the City of Annapolis,

SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that the Code of the City of Annapolis shall be amended to read as follows:

TITLE 11 - PUBLIC PEACE, MORALS AND WELFARE

Chapter 11.12 - PUBLIC PEACE AND ORDER

Section 11.12.020 - Noise prohibition.

- A. Sections Code of Maryland Regulations 26.02.03.01 and 26.02.03.0326.02.03.02 of the Code of Maryland Regulations (COMAR), as amended from time to time, are hereby adopted as the Environmental Noise Standards of the City of Annapolis with the following amendments:
 - 1. except that the maximum decibel levels allowed within the City of Annapolis are set forth in the following table, which table shall supersede Code of Maryland Regulation 26.02.03.02 Table 1 Table 2 in Section 26.02.03.03 is amended to read as follows:

Area or activity	Maximum decibe	Maximum decibel level may not excee	
	Daytime hours of a.m. to 10 p.m.	7Nighttime hours of p.m. to 7 a.m.	
Residential zoning districts as identified in Chapter 21.40	65 dBA	55 dBA	
Office and mixed use districts as identified in Chapter 21.44	67 dBA	62 dBA	
Commercial and industrial zoning districts as identified in Chapter 21.42	75 dBA	75 dBA	

- 2. Subsection C of Section 26.02.03.03 is stricken.
- B. Sections Code of Maryland Regulations 11.14.07.02 through 11.14.07.12 of the Code of Maryland Regulations (COMAR), as amended from time to time, are hereby adopted as the Motor Vehicle Noise Standards of the City of Annapolis.
- C. A violation of this section is subject to penalty pursuant to section 11.12.120.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this ordinance shall take effect from the date of its passage.
