**AN ORDINANCE** concerning

**City Council Meetings - Rules of Procedure**

**FOR** the purpose of modifying the time to present petitions, reports, and communications.

**BY** repealing and re-enacting with amendments the following portions of the Code of the City of Annapolis,  
2019 Edition  
2.16.035

**SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

**Title 2 - ADMINISTRATION**

**Chapter 2.16 - RULES OF PROCEDURE**

**2.16.035 - Time limitation-Petitions, reports and communications.**

A person appearing before the City Council with a petition, report or communication shall be limited to a presentation of not more than ~~five~~THREE minutes. The time specified in this rule may be changed at any time by a majority vote.

**SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
