**WHEREAS**, R-20-20 amends the FY 2020 Fees Schedule to specify the fees that will be charged for use of the new City of Annapolis swimming pool effective April 1, 2020.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2020 Fees Schedule shall be amended as follows:
