**WHEREAS,** Ordinance 48-20 adds Sections 8.04.050 and 8.04.060 to the Annapolis City Code that regulate dogs at large and dogs in public recreation areas, respectively; and

**WHEREAS,** Resolution 64-20 adds the fines for violations of Sections 8.04.050 and 8.04.060 of the Code of the City of Annapolis.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fiscal Year 2021 Fines Schedule is amended as follows:

Code Reference			Fine for Repeat or Continuous Violations
8.04.050	DOGS AT LARGE	\$250.00	\$500/DAY
	DOGS IN PUBLIC RECREATION AREAS	\$250.00	\$500/DAY

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this resolution shall become effective upon the passage of Ordinance 48-20.
