**FOR** the purpose of amending Annapolis Police Department fees; and generally related to the FY 2023 fee

**WHEREAS**, Pursuant to Section 6.16.050, the proposed annual budget and schedule of fees was approved by the Mayor and City Council effective June 10, 2022; and

**WHEREAS**, Certain fees in the Fees Schedule pertaining to Title 2 require revision; and

**WHEREAS**, The State of Maryland raised its processing fee for fingerprinting services, R-58-22 amends the FY 2023 Annapolis Police Department fee schedule for certain fingerprinting services in response to the Maryland Department of Public Safety and Correctional Services processing fee increase.

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2023 Fees Schedule shall be amended as follows:
