19 **FOR** the purpose of updating the Fees to add a rooming house operating license fee and to
20 amend existing rental license fee descriptions in connection with Ordinance 11-26, which

25 **WHEREAS,** O-11-26 authorizes Rooming Houses in the City of Annapolis and requires
26 licensing fees to cover the City's cost of implementing the program;

28 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
29 the Fees Schedule shall be amended as follows:

Section	Type of Fee	Amount of Fee
17.44.030.B	Short term rental license for type of premises listed in 17.44.010.A <u>§ 17.44.030.A</u> other than bed and breakfast homes, hotels, motels, <u>rooming houses</u> , or inns	\$400.00
