9	B. Mobile Food Service Vendors <u>(also known as "food trucks")</u> .
10 11 12	1. <b>Historic District.</b> Mobile food service vendors are allowed in the City's Historic District, as defined in § 21.56, only as part of a special event organized by the City per §14.18.
13 14	2. <b>Outside the Historic District.</b> In areas outside the Historic District, mobile food service vendor licensees may operate as follows:
15	a. On private property only with the express written permission of the:
16 17	i. Property owner, which permission shall include a starting and ending date;

2 3	i. <u>All signage pertaining to or advertising a mobile food service</u> vehicle and/or its menu shall be attached to the vehicle.
4 5	ii. No part of a sign attached to a mobile food service vehicle shall extend more than 18 inches from the vehicle.
6 7 8	iii. A mobile food service vehicle shall not be outfitted with a "changeable electronic variable message sign" or "prohibited sign" as set forth in subsection c (below).
9 10	b. Sight Visibility. No sign shall obstruct a clear view to and from traffic along any street right-of-way, entrance or exit.
