14 **A RESOLUTION** concerning

15 **Authorizing Itinerant Merchant Sales Within the Annapolis Historic District for**
16 **Approved Special Events During Calendar Year 2026**

17 **FOR** the purpose of authorizing hawker, peddler, and itinerant merchant sales in the Historic
18 District as part of approved Special Events during the calendar year 2026.

19 **WHEREAS,** The Annapolis Historic District is a nationally recognized area of significant
20 architectural, cultural, and historical importance that attracts residents, visitors,
21 and tourists from across the region and beyond; and

22
23 **WHEREAS,** The City Council has authority under Article III, Section 15 of the Annapolis City
24 Charter to regulate the licensing and operation of hawkers, peddlers, and itinerant
25 merchants within the City's boundaries, and under § 7.40.090 of the City Code,
26 hawkers, peddlers, and itinerant merchants must obtain a license and satisfy
27 specific conditions, including requirements applicable to business conducted
28 within the Historic District; and

30 **WHEREAS,** Chapter 14.18 of the City Code states that regulating Special Events in the City is
31 in the public interest, and it outlines the criteria for designating and authorizing a
32 Special Event, mandating that a permit be obtained from the City's Special Events
33 Coordinator, who must seek input from the appropriate City departments; and

35 **WHEREAS,** The City Council has determined that allowing itinerant merchant activities in
36 designated areas of the Historic District during the year 2026, in conjunction with
37 approved Special Events, will help achieve the City's goals of promoting local

1 economic development, supporting entrepreneurship, and creating a vibrant public
2 space; and

4 **WHEREAS,** This approach also aims to protect public health, safety, and welfare, minimize
5 impacts on permanent businesses, and preserve the district's historic and aesthetic
6 character; and

8 **WHEREAS,** The following applicants have applied to hold Special Events in the City's
9 Historic District during calendar year 2026:
