# City of Annapolis



- Colonial Town – Province of Maryland
- Severn River / Chesapeake Bay
- 25 miles from Baltimore
- 30 Miles from Washington
- Founded in 1649 – One of the Country's Oldest Cities

# State Capital



- Capital of the State of Maryland
- Oldest State Capital in Continuous Legislative Use
- Constructed in 1772
- Served as the Capital of US (1783-1784)

# Maryland State House



- Served as the Seat of Confederation Congress
- George Washington resigned his Commission as Commander of the Continental Army
- Congress Ratified the Treaty of Paris of 1783

# Saint Johns College




- Established 1784

- Private Liberal Arts College
- 36 Acre Campus
- Sits on College Creek

# United States Naval Academy



- Established 1845
- Second Oldest Military Academy
- 338 Acre Campus – Known as the Yard
- Bancroft Hall – Largest Dormitory in the US
- Home of over 4000 Midshipman
- Protected by Naval District Washington Fire and Emergency Services – NSA Annapolis

# Annapolis Fire Department



- 1803 – City Acquired a Hand-Pumper
- 1821 – Housed in City Hall – Engine House
- 1839 – Independent Volunteer Fire Company – Authorized by the Maryland General Assemble(Disbanded during Civil War

- 1879 – Rescue Hose Company No. 1
- 1884 – Independent Fire Company No. 2
- 1885 – Waterwich Hook and Ladder
- 1886 – Eastport Fire Company
- 1911 – West Annapolis Fire and Improvement Company
- 1964 – First Career Fire Chief
- 1972 – Forest Drive Station
- 1987 – Taylor Avenue Station



# Annapolis Fire Department

## Line of Duty Deaths



### **March 6, 1910 - Firefighter William H. Brown** **Water Witch Hook and Ladder Company Number 1**

Firefighter Brown fell from a ladder while fighting a fire at Market Space and Fleet Street in Annapolis. His injuries were initially believed to be minor; however, he died later that night at his home from massive swelling of the brain.

### **July 13, 1958 - Firefighter Alexander C. Johnson** **Rescue Hose Company Number 1**

Firefighter Johnson died of an apparent heart attack after he responded to a kerosene stove fire on Shaw Street and went home when he complained of not feeling well.

### **September 7, 1964 - Firefighter John W Schwallenberg** **Rescue Hose Company Number 1**

Firefighter Schwallenberg, one day before his 17th birthday, died from smoke inhalation while fighting a fire in a warehouse at Virginia Avenue and Chinquapin Round Road in Annapolis. It is believed that he, along with 2 other firefighters, entered the warehouse from the opposite end where the fire started and was enveloped in smoke and although wearing breathing apparatus was still overcome in the conditions of the fire.



# ISO Rating – Class 1

- Insurance Services Office (ISO)
- Independent agency that provides rating of fire protection services for insurance underwriters.
- Rating – Class 1-10 ( Class 1 - being outstanding, Class 10 - being no fire protection).
- Factors considered - Water supply (fire hydrants/static water sources, fire engine & ladder truck deployment, staffing, training, fire dispatch (911), community risk reduction (fire prevention) and fire investigation (arson) program.
- We are one of only four Class 1 fire departments in the State of Maryland and 242 of 27,201 in the nation. (includes over 51,000 fire stations)

# IAFF Local 1926



- The uniform personnel in the ranks from Firefighter through Captain are represented by the International Association of Firefighters (IAFF) Local 1926.
- The Fire Department Administration has a great working partnership to support the mission of the Annapolis Fire Department.





# Volunteer Fire Service

- Three (3) Volunteer Fire Companies in City
  - Eastport, Independent, Rescue Hose
- City owns all City fire stations
- Supportive role:
  - Eastport (very supportive) - owns 2 fire engines, 1 medic unit, 2 ATV (gators), pick-up truck w/snow plow.
  - Independent – owns a pick-up truck w/snow plow and small rescue boat.
  - Rescue Hose – owns no vehicles or apparatus.



## • City of Annapolis Resolution R-4-98

- Established a Fire Safety Commission Report
- Concerns for Public Safety and Protection of the Historic District
- Published a Report on July 27, 1998
- 21 Recommendations
- Adopt NFPA 909 (includes Historic Properties)
- Consider Parking Restrictions for Narrow and Congested Streets
- Hire a Licensed Fire Protection Engineer
- Consider Tax Credits for Monitored Fire Alarms and Sprinkler Systems
- Schedule Funding to Underground Overhead Wires
- Hire an Additional Inspector
- Fill Vacancies in the Fire Department

# Ordinance O-1-22



Fire Prevention Code - Sprinkler Systems - For the purpose of requiring property owners to install sprinkler systems; encouraging property owners to solicit bids from licensed minority business enterprises; identifying loan eligibility requirements under the sprinkler assistance revolving fund; clarifying costs that may be funded; establishing a loan amount; identifying loan repayment criteria; setting a date for sprinkler installation compliance; identifying the responsibility of applicable property owners; identifying the appropriate body for appeals; and generally relating to the Fire Prevention Code.

# Ordinance O-1-22



## Applicability.

- All commercial, mixed-use, and residential buildings other than a single-family house located on Main Street and Francis Street in the Historic District shall install sprinkler systems.
- If the building is adjacent to existing underground lateral lines, sprinkler systems shall be installed no later than February 28, 2027.
- If the building benefits from installing adjacent underground lateral lines after February 28, 2022, sprinkler systems shall be installed no later than five years after the lateral lines are installed.

## Requirement to Have Fire Sprinkler System.

- All buildings in this section shall have a fully functioning fire sprinkler system.
- When activated, the system shall immediately and automatically alert a 1 monitoring service, through a National Fire Protection Association (NFPA) 72 compliant control panel.




