Why are you interested in serving on a board or commission?

Annapolis's recreation and park system is one of the most visible and meaningful ways residents experience local government. When our parks are welcoming, well maintained, and thoughtfully designed, they strengthen community, improve public health, and create common ground for people with very different interests. I want to serve on the City of Annapolis Recreation Advisory Board because I believe Annapolis deserves world-class recreational facilities that reflect the needs of a diverse population, and I want to help the City make practical, well-informed decisions that improve access, enjoyment, and long-term stewardship for everyone. I'm especially motivated to serve because I've been deeply involved in Annapolis Waterworks Park since 2018, where I've led volunteer efforts to design, build, and maintain a 14-mile natural-surface trail system that has become a major recreational asset for City residents. Through this work, I've coordinated volunteers, partnered with stakeholders, and helped raise more than \$40,000 from residents, local businesses, and grants to support new recreational facilities at the park. Serving on the Advisory Board would allow me to bring the perspective of Waterworks Park users into City planning and help ensure this special resource continues to be maintained and improved in ways that serve the recreational needs of City residents. I also bring experience in collaborative recreation planning beyond Annapolis. I served on the Anne Arundel County Crownsville Hospital Memorial Park Advisory Committee's Recreation and Parks Subcommittee, working with a diverse group to propose facilities and connections - including trail links between regional parks and a variety of recreation options - so that a broad range of residents feel included. In addition, as a board member and secretary for a regional trails nonprofit, I have direct experience running board meetings and handling required filings, all skills that translate well to advisory board service. Professionally, I'm an attorney who chairs an energy and environmental practice group at a major Maryland law firm, with substantial experience navigating public decision-making, rulemaking processes, and stakeholder engagement. I've drafted and supported major legislation and worked extensively in regulatory proceedings. My extensive professional experience would help me evaluate proposals carefully, ask the right questions, and communicate recommendations clearly and constructively. I would be honored to bring this combination of hands-on recreation experience and public-process expertise to the Recreation Advisory Board to help Annapolis continue building recreational opportunities that residents are proud of and excited to use.
