Pending your approval, I would like to reappoint Ms. Janet Norman to the Education Commission. Ms. Norman has served on this commission since 2012.

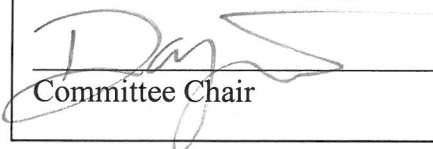
