Finance Committee Amendments/Recommendations -

#### Planning and Zoning:

Alderwoman Finlayson requested the "Economic Diversity Specialist" be changed back to "Small Minority Business Liaison".

Alderwoman Finlayson requested a code change for Arts in Public Places Commission (AIPPC) to be placed under Planning & Zoning Department.

#### **Police Department:**

Alderwoman Finlayson moved to Include "Adopt a Community" grant program and "Community Ambassadors" be included in the community policing program. Seconded. CARRIED on voice vote.

Alderwoman O'Neill moved to put a place holder that indicates the Finance Committee supports adding additional funding for additional speed cameras in the city. Seconded. CARRIED on voice vote.

#### **Fire Department:**

Alderman Huntley requested Chief Remaley confirm the reasons he needs his own IT specialist.

Alderwoman O'Neill requested an estimate for how much it would cost to add an IT position to the Fire Department.

#### Fees & Fines:

Alderman Huntley moved to amend Fine 7.12.100.C strike and "exceed 90 days in jail" from "Fine for Initial Offense" and "Fine for Repeat or Continuous Violations". Seconded. CARRIED on voice vote.
