

F. Joseph Rubino

Mr. Rubino is currently the Chief Financial Officer and Deputy Superintendent for Finance for the United States Naval Academy in Annapolis, Maryland. These duties include responsibility for Comptroller Department, Human Resources Department, business services, non-appropriated fund instrumentalities, Transportation Department, service on the Naval Academy Athletic Association Board of Control and ex officio service with the Naval Academy Alumni Association & Foundation Joint Finance and Audit Committee. He arrived at the Naval Academy in the spring of 2001 as the Director, Financial Requirements and Resources. He has performed many duties for the Naval Academy including Director Governmental Affairs, facilities programming, Supply Officer, and Director of the Naval Academy's efforts in support of the Annapolis Peace Conference. In the spring of 2008 Mr. Rubino established the Naval Academy's first diversity office and became its first Chief Diversity Officer.

Mr. Rubino retired from the Navy in October 2000 following twenty years of service in the U.S. Navy Civil Engineer Corps. His final military assignment was Legislative Liaison in the Department of Navy's Office of Legislative Affairs, Washington, D.C.

He was commissioned in the U. S. Navy Civil Engineer Corps in 1981 after graduation from Villanova University with a Bachelor of Science degree in Civil Engineering. He received a Master of Science degree from the Massachusetts Institute of Technology in 1989, and a Jurist Doctor from Temple University School of Law in 1994.

Mr. Rubino is a native of Annapolis, Maryland. He is involved in the Annapolis business community and serves on various local boards and commissions. He is married to the former Amy Peckham of Rockville, Maryland. The Rubinos have three children, Anthony (33), recently completed studies in Tokyo following service in USMC, Jessica (30), a planner with the Chesapeake Bay Foundation, and Caroline (29), an analyst for Meta/Facebook.
